The meeting was called to order at 10:15 a.m. by Mayor Wagner after which he led his Councilors in reciting the Belize National Prayer.

Mayor Wagner congratulated Councilors Arnold, Pollard Jr. and Pitts for having contested the recent General Elections. Mayor Wagner stated that he would like to see the same energy and enthusiasm that was displayed during the General Elections displayed during the campaign that will lead up to the 2021 Municipal Elections. Mayor further stated that he would support whatever decision his Councilors make going forward.

Councilor Castellanos stated that it was a pleasure to be a part of the team and that everyone has collectively become a family.

Deputy Mayor Norales reminded everyone that he had indicated, at the onset, that he would have served for one term only.

## 1.0 Ratification of March 11, 2020 Minutes

- 1.1 Councilor Goodin moved for the Minutes to be accepted as is. Councilor Castellanos seconded.
- 2.0 Matters arising from Minutes
- 2.1 Proposed Settlement in Civil Appeal No. 18 of 2019 The Mayor of Belize City/Belize City Council v Candice Miller
- 2.2.1 Mayor Wagner informed that the Council received a letter, dated November 10, 2020 from Ms. Candice Miller's attorney which informed that the Claimant has reduced her previous proposed settlement.
- 2.2 Procurement of Heavy-Duty Equipment Deputy Mayor Norales informed that a meeting was held which had the participation of the Mayor, the Deputy Mayor, the City Administrator and Mr. Donald Sampson of Seremei LLC. Deputy Mayor Norales shared that the heavy-duty equipment will be ready on November 27, 2020.
- 2.2.1 Mayor Wagner commended Deputy Mayor Norales for his leadership in procuring the heavy-duty equipment for the Council's Sanitation Department and stated that it represents another clear example of the Council's proactiveness.
- 2.3 Mayor Wagner stated that one major project that the Council will undertake in the next will be the establishment of a "one-stop" Traffic Department. Mayor Wagner shared that the City Planner and the Building Unit Manager will be tasked with identifying a suitable space at the Works Department compound and creating a building design.





- 2.4 Councilor Arnold emphasized the importance of developing a sound maintenance plan for the recently acquired heavy-duty equipment.
- 2.5 Mayor Wagner stated that the heavy-duty equipment will be instrumental for the Council's annual Christmas cleanup campaign.
- 2.6 Mayor Wagner stated that the Council will focus primarily on drains, streets and abandoned lots over the course of the next three months.
- 2.7 Mayor Wagner tasked Councilor Elijio and the Building Unit with addressing damages to portion of sidewalk that have been caused by Belize Dry Cleaners.
- 2.8 Councilor Pitts recommended a name change for the Michael Finnegan Market. Mayor Wagner stated that the Market would first have to be rebranded.
- 3.0 Mayor's Motions/Announcements/Matters
- 3.1 Fuel Purchase Agreement with Oil & Energy Export Limited
- 3.1.1 Mayor Wagner shared the Council intends to enter into a fuel purchase agreement with Oil & Energy Export Limited. Mayor Wagner stated the Council has established a credit line with the fuel supplier in the amount of \$15,000.
- 3.1.2 Mayor Wagner moved a motion for the approval of a fuel purchase agreement with Oil & Energy Export Limited. ALL Councilors voted in favor – MOTION PASSED.
- 3.2 Asset & Investment Agreement Bet/BCC and M.Y. Investments Ref: Installation of LED Digital Billboards on Pallotti Overpass
- 3.2.1 Mayor Wagner stated that the Council will formalize an asset & investment agreement with M.Y. Investments for the installation of two LED digital billboards on the Pallotti Overpass.
- 3.2.2 Councilor Elijio stated that the Council should be collecting revenue from Brodies Downtown for the installation of its digital billboard.

- 3.2.3 Mayor Wagner moved a motion for the approval of an asset & investment agreement between the Belize City Council and M. Y. Investments for the installation of two digital boards on the Pallotti Overpass. **ALL** Councilors voted in favor **MOTION PASSED**
- 3.3 Counter-Offer from Candice Pitts
- 3.3.1 Mayor Wagner informed that Ms. Candice Miller has reduced her proposed settlement.
- 3.3.2 Deputy Mayor Norales, Councilors Vaughan, Elijio and Pollard Jr. stated their objections to the Claimant's counter-proposal after which it was unanimously agreed that the Council will discontinue negotiations and move ahead with its appeal of the judgement.
- 4.0 Mayor Wagner stated that the confirmation of the composition of the Council's Boards are due to the Ministry of Local Government.
- 4.1 Councilor Vaughan recommended that Mr. Kevin Lee be appointed to the Belize District Liquor Licensing Board. Councilor Goodin recommended himself to be appointed to the Board.
